Collecting data on gender identity can help identify patterns and disparities in determinants of health and health outcomes for different groups. The data could also enable identification of any geographic areas where there are high proportions of people who identify as non-binary or as a different gender to that recorded at birth. Identification of these patterns would inform policies and health and social services planning and delivery, to better meet the needs of gender diverse people and provide for a more equitable society.

Data on smoking status is of national importance because tobacco smoking is still the single most important preventable cause of ill health and death in Australia. ([AIHW, 2022](#))

Additionally, data on vaping status/e-cigarette use is of national importance due to the growing rates of e-cigarette use, particularly among young people. ([Watts et al. 2022](#)) As a youth-focused organisation, we at Canteen are particularly aware and concerned about vaping rates among young people. Vapes have been found to contain a cocktail of chemicals, many of which are known to be toxic and there is increasing evidence that e-cigarettes pose significant health risks. ([Larcombe et al. 2021](#))

Population-level smoking and vaping status data is critical to understanding and addressing the ongoing impacts on health systems of tobacco smoking and the emerging issue of vaping which may have significant impact on our health systems in the future unless we take urgent action with data-driven solutions.

Current sampling, such as the [NSW Population Health Survey](#) is not adequate to determine smoking and vaping prevalence in priority populations or to reliably detect changes over time.

National, population-level data on smoking and vaping status is needed to understand use among priority populations such as Aboriginal and Torres Strait Islander people, people with diverse sexualities and genders, people living in regional and remote Australia, people with disabilities, people with lower levels of education and people from low socioeconomic areas.

Including questions about smoking and vaping status on the Census would provide reliable data to assess progress towards reduced use of tobacco and nicotine products including use among small priority populations. Census data on smoking and vaping would inform policies, health and social services planning and delivery, targeted health promotion and prevention campaigns, and evaluation of the [National Tobacco Strategy 2022-2030](#).
